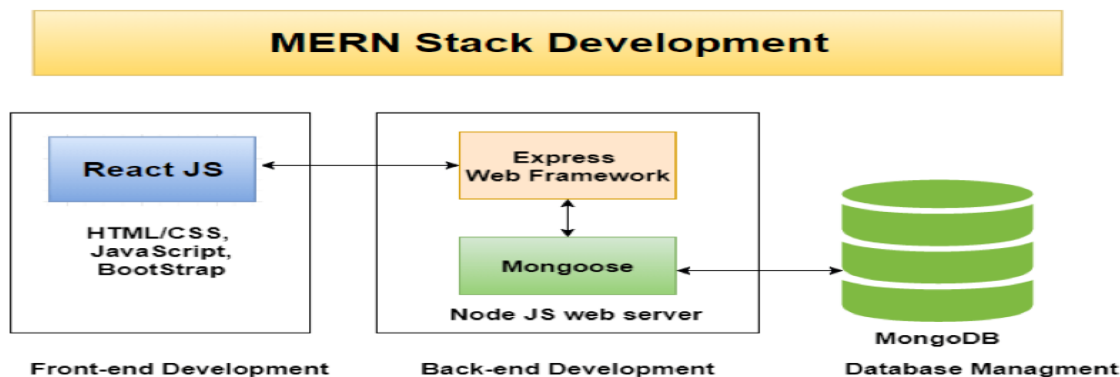


Figure 1: MERN Stack Development

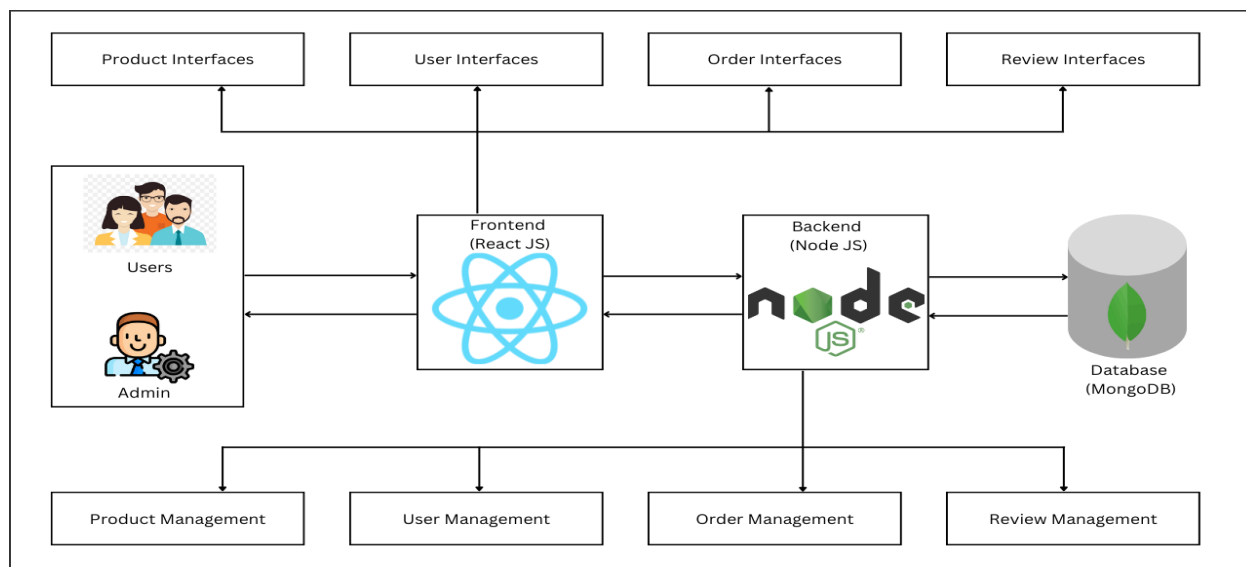


Figure 2: System Overview

We have successfully concluded the functional tests. The results are following below. Code quality is maintained up to optimum level. Code is separated into several components.

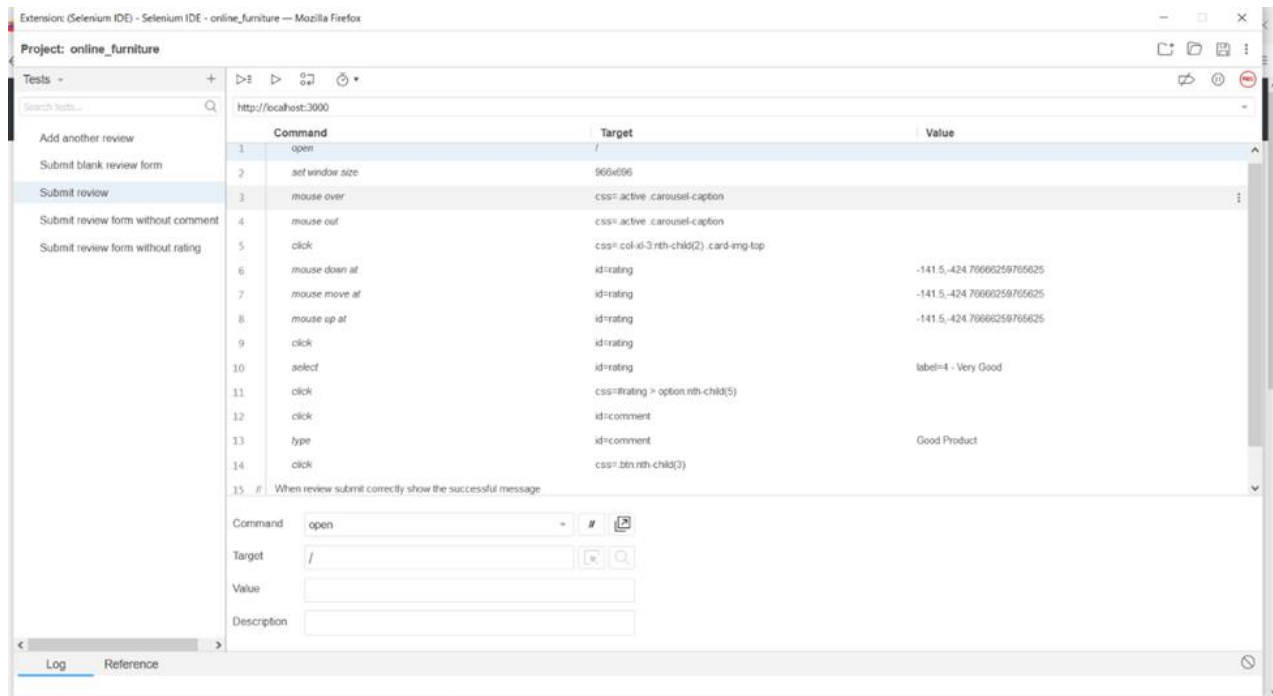


Figure 3: Test cases – submit review

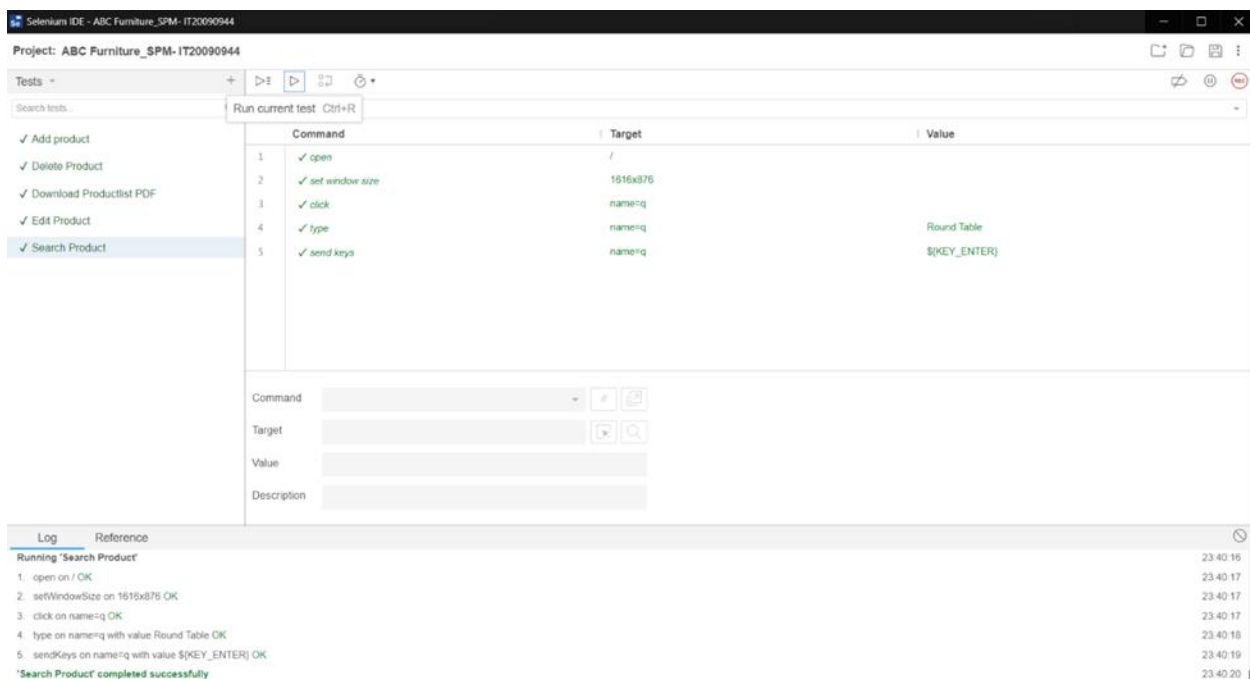


Figure 4: Test result – search product
